And

The University of Selangor (UNISEL) Malaysia

The Memorandum of Understanding (hereinafter referred to as "MoU") is made on the November

th 2018 by the following parties: The State Institute for Islamic Studies (IAIN) Salatiga Indonesia (hereinafter referred to as the First Party) and The University of Selangor (UNISEL) Malaysia (hereinafter referred to as the Second Party). The First and Second Party are jointly hereinafter referred to as the "Parties".

The Parties are in agree to collaborate in the field of education, instruction, journal and research, Seminar and community service elaborated as stated in the following articles.

Article 1

PURPOSE AND SCOPE

The Parties are in agree to conduct a mutual beneficial collaboration in the development of education, instruction, journal and research, Seminar and community service.

Article 2

RESPONSIBILITIES AND AUTHORITIES

- The Parties are in mutual to collaborate each other, within their limit of authorities on the development of sources pertaining to education, instruction, journal and research, Seminar and community service.
- 2. The collaboration between the Parties will address:
 - a. Providing experts to strengthen and develop the Islamic studies;
 - b. Developing the Islamic Curriculum;
 - c. Exchanging lecturer/examiner in specific discipline;
 - d. Exchanging student in specific discipline;
 - e. Training prospective lecturer intensively;
 - f. Conducting joint research and Seminar;
 - g. Conducting Professor Visiting program;
 - h. Publishing journal and scientific writin.

Article 3

IMPLEMENTATION

The detail implementation of the programs will be regulated by the Parties in the supplement of MoU which is inseparable to this MoU.

Article 4

COST AND EXPENSES

All costs and expenses arising from this MoU will be regulated in particular addendum in accordance with the existing expense regulation of the Parties.

Article 5

CLOSING

- 1. This MoU is made on the base of good intention of the Parties for a better development.
- 2. Any dispute of conflict arising out or in connection with this MoU will be settled by a deliberation.
- 3. Any changes of this MoU should be agreed by the Parties.
- 4. This MoU is valid for 5 (five) years and could be renewed.
- 5. This MoU is made double and kept by the Parties.
- 6. The operation of this MoU will be effective after being signed by the Parties.
- 7. Any matters pertaining to this agreement, yet unstated, or necessary changes will be regulated in the supplement of the MoU.
